Limited Warranty For PV Modules

Yanghao international Ltd. (hereafter “YHL”) underwrite the following limited warranty on the photovoltaic modules(hereafter “ modules”) provided by Aurora PV, according to the terms and conditions stipulated below:

1. LIMITED WARRANTY OF MATERIAL AND WORKMANSHIP (HEREAFTER “PRODUCT WARRANTY”)

Aurora warrants that the modules are free from defects in material and workmanship under normal conditions of use, installation, operation and maintenance, within a period of **TEN (10) year** as from the date of delivery.

If a module is found defective in material and /or workmanship, Aurora will, at its sole discretion, repair or replace the module within 6 weeks of reported fault.

If Aurora are unable to repair and replace the module within the stipulated time, they will compensate the buyer to the market value of the module at the time of replacement.

2. LIMITED WARRANTY OF OUTPUT (HEREAFTER “OUTPUT WARRANTY”)

YHL warrants that if (a) a module supplied less than 95% of the minimal output specified at delivery within a period of 5 years as from the date of delivery, or (b) a module supplied less than 90% of the minimal output specified at delivery within a period of 12 years as from the date of delivery ,or (c) a module supplied less than 80% of the minimal output specified at delivery within a period of 25 years as from the date of delivery .

YHL will, at its sole discretion, repair or replace the module, or deliver additional module(s) to compensate the loss of the output, provided that such a loss of output is attributable to defects in material and /or workmanship by the diagnosis of independent test body.

If Aurora is unable to repair and replace the module within the stipulated time, they will compensate the buyer to the market value of the module at the time of replacement.

Repair, replacement, and additional delivery are the only and exclusive performances guaranteed under this Output Warranty which is limited to the above specified period(s).

All freight and delivery charges relating to the replacement of the faulty module will be borne by Aurora.

3. WARRANTY EXCLUSIONS AND LIMITATIONS

The above Limited Warranties are not applicable, should an independent test body, agreed by both parties, determine that the module has been incorrectly operated, or inappropriately used, or exposed to accidents, or damaged by misuse, by modification, by unsuitable installation or use, by negligence with storage, transport or handling, or repaired or modified –in whatever manner-by anyone other than Aurora or it’s authorized third party.

Further exclusions of the limited warranties include defects:

- Caused by outer impacts, e.g. defective equipment parts, appliances, system components like bypass diodes, connecting cables, invertors, or the like, which have been coupled with the module by anyone other than YHL, or caused by defective system design, configuration, or installation planning.
- Caused by faulty wiring or installation, or faulty handling during these work;
- Caused by operation in inappropriate environment or with inappropriate methods, which deviates from the instructions in product specification, and/or operational manual and/or label;
- Caused by other external impacts such as mud on the front glass, pollution or damage due to smoke, salt, acid rain, etc;
- Caused by use on mobile objects such as automobiles, ship, etc;
- Caused by force of nature, force majeure, or other unforeseeable circumstances outside of the range of the influence of YHL, for instance, earthquake, typhoon, whirlwind, volcanic eruption, flood, lightening, snow damage, etc.

The Limited Warranties do not cover any cost associated with installation, removal or reinstallation of the PV modules. The above warranties replace as well as exclude all other explicit or implicit warranties-including but not only including-those from commercial law(s) (including the liability of the importer) and those of the suitability for a particular application, and all other obligations and liabilities on the part of AURORA PV, unless those warranties, obligations and liabilities are expressly agreed to in writing signed and approved by YHL.

YHL is not liable for any incidental, consequential, or punitive losses and /or damages. YHL's aggregate liability, if any, in damages or otherwise, shall not exceed the invoice value as paid by the customer, for the unit of product or service furnished or to be furnished, as the case may be, which is the subject of claim or dispute.

4. Obtaining Warranty Performance

If the Customer feels he/she has a justified claim covered by this Limited Warranty, he/she must immediately notify the (a) dealer, who sold the PV-modules, or (b) any authorized YHL distributor, of the claim in writing, or (c) send such notification to YHL in Sydney, Australia. Together with the notification Customer should enclose evidence of the date of sale on which the Solar Products have been purchased. If applicable, Customer's dealer or distributor will give advice on handling the claim. If further assistance is required, Customer is invited to write for YHL instructions. The return of any PV-modules will not be accepted unless prior written authorization has been given by
